## 2.A. <u>DISCUSSION: Adoption of Proposed Millage and Dates/Times/Places for Public</u> <u>Meetings</u>

Cindy Lawson discussed discussed the 2007-2008 proposed millage rate, the special district requirements and the proposed legislative rollback.

The first version of the draft budget reflects a proposed millage rate equal to last year's adopted millage rate of 0.7537. In order to achieve this proposed millage rate, an additional \$20,531 would need to be cut from the draft budget.

The second version of the draft budget reflects a proposed millage rate at the current year "rollback rate" of 0.6881. In order to achieve this proposed millage rate, an additional \$260,771 would need to be cut from the budget to achieve a balanced budget.
